The Blue Earth County Targeted Ditch inventory was developed to conduct an inventory and evaluation of four county ditches systems. The inventory will document specific items of interest including tile inlets, sedimentation, erosion, sloughing and the overall condition of each system. the inventory is these ditch systems will also identify areas where best management practices (BMPs) can supplement drainage project utilizing methods aimed at reducing peak flows and erosion, trapping sediment, reducing nutrient loading and improving water quality throughout each watershed and their receiving waters.

### **Project Deliverables**

- A report defining multi-purpose drainage management best management practices (BMPs) that can be applied to an open ditch system or throughout a watershed will be created.
- The report will identify water quality preventive measures that can be applied to the existing landscape without dramatically changing the current land use. Preventive

- measures identified in the report include cover crops, residue management, nutrient Management and Crop Rotation
- The report will identify water control structures for water control structures and include a variety of weirs, drop inlets, stop log weirs, culverts or baffles and the possible establishment of two stage ditches. The water quality benefits associated with these structures include sedimentation, reducing flow rates and providing wildlife habitat.
- The report will be presented to the landowners of the four targeted watersheds

- At the September 2, 2015 landowner meeting the CD 56 landowners requested Blue Earth County Soil and Water and the Blue Earth County Drainage Authority apply for grants to implement some of the BMPs listed in the report.
- At the February 26, 2016 landowner meeting the CD 56 landowners requested the alternative side inlets be installed during future repairs to the system.
- At the March 2, 2016 landowner meeting the CD 86 landowners supported the report recommendations to replace intakes with the alternative side inlets recommended in the report. There was also support for the enhancement of the two stage ditch that is naturally forming along portions of CD 86.
