Summary from Residents:

Language access planning and providing information in different languages is vital

Concerned with guest policy – have family from other counties and they come for a couple weeks to a month – assured them that this policy does allow for that and accommodations can be made on case by case basis.

Homeownership was greatly appreciated and additional assistance to help understand home maintenance would be beneficial.

Homeownership encouraged other participates to consider and give themselves enough time to shop for home – not just take the first one that they look at – he felt he should have taken more time.

Other families were interested in homeownership

Families looking for assistance in budgeting and money management, eliminating debit.

Responses from mailing and Pioneer Plaza resident meeting:

“Nicest place I have ever lived, feeling very blessed!”

Add to pet policy – yearly statement showing up to date vaccines.

Pest control spraying inside and outside of units. (staff currently sprays outside, inside on service requests)

Gutter cleaning frequently to prevent water overflows. (staff has done twice and will do more as needed)

Check roof for leaks, concern for black spots being mold. (staff has responded to concerns and found not leaks, piping properly connected, no signs of mold)
